1. Applicants

The course is open to at a maximum of 5 candidates of any nationality between 18 and 30 years old.

2. Purpose of the course

The course is aimed at training tailoring support staff for dressing, basic maintenance, small repairs and small tailoring interventions. The professional figure of the stage tailor finds application both in theatres, opera houses, touring companies, but also in the concert, television, cinema, trade fair and fashion sectors. The learning process is supported by various periods of work experience within Teatro Coccia productions.

3. Duration

The course is annual and will take place at the Coccia Theater in Novara in several noncontinuous periods from JANUARY 2025 to DECEMBER 2025. The lessons will be planned in accordance with the Theater's programming, with particular attention to musical theater productions and in parallel with the lesson of the other courses. In the event of interruption of the course "due to force majeure", we will proceed with Distance Learning mode via the dedicated online platform for theoretical lessons, while practical ones and work experience periods will be postponed.

At the end of the course, a certificate of attendance will be issued, subject to satisfaction of the conditions set out in point 8 of this Open Call (see below).

4. Training program

The course will be structured in a total of 250 hours including hours of study and independent exercises in the classroom without a teacher (in order to allow students to make use of spaces and materials) and 70 days of work experience.

The study program is designed to help students gain confidence with the practical techniques taught during the lessons, ensuring they are well-prepared to participate in the productions of the 2025 season.

The calendar of lessons may undergo changes which will be communicated to the students promptly.



5. Application procedure

Requirements:

Good manual skills and minimal familiarity with needle and thread are required. To access the selection, it is necessary to send the following documents by email (subject of the email "AMO - COURSE FOR STAGE TAILORS"):

- 1. This **Open Call** filled in all its parts and initialed on each page;
- 2. Completed registration form (attachment A) with copy of the identity document and tax code

NB: (foreigners are also required to send valid visa / permit of stay, or adequate documentation certifying their renewal);

6. Selections

Students deemed suitable through the evaluation of their CV by the Teacher will be admitted to an in-person interview and a subsequent practical-manual test which will be held at the Coccia Theater in Novara at the end of October 2024.

7. Deadlines and terms

- a. no later than midnight GMT+1 on Tuesday 01 October 2024, applications for admission, accompanied by what is indicated in point 5, must be sent to the email address segreteria.amo@fondazioneteatrococcia.it
- b. by Wednesday 16 October 2024, suitable candidates will be notified of the day and time of the interview via email;
- c. at the end of the interviews the names of the candidates admitted to the course will be communicated.

8. Costs and conditions of participation

The course participation fee for admitted students is €900.00 (VAT included).

The participation fee must be paid in 2 installments of €450.00 each by bank transfer to Fondazione Teatro Carlo Coccia di Novara IBAN IT 80 X 05034 10100 000000042424



1st installment deadline: by 18 December 2024 2nd installment deadline: by 27 February 2025

If the installments are not paid on time as specified, attendance at the course will be suspended.

Students residing outside the regions of Piedmont and Lombardy will be able to take advantage of the 2025 accommodation agreements.

Attendance at the course is mandatory both for the theoretical hours and for the exercises without a teacher, as well as for the work experience hours for which the active participation of all students of the course is required. Any needs that may partially compromise participation in lessons and productions must be communicated to the academy secretariat.

Through special promotions, students will have the opportunity to attend the season's scheduled shows at the Coccia Theater in Novara as audience members.
